

PTO Board of Directors Meeting Agenda Feb. 9, 2022, 3:45pm via Zoom

- 1. Call to Order; By President Katrina McLaughlin @ 3:46pm
- 2. Roll Call; By Secretary Sara Erdmann
 - a. In attendance: Katrina McLaughlin, Kirsten Wall, Julia Navik Gutierrez, Theresa Meshes. Sara Erdmann and Rachel Herndon
- 3. Approval of Meeting Minutes; Board
 - a. Our January meeting minutes were approved by the board via email and posted to the PTO website.
- 4. Business
 - a. Correspondence; Sara Erdmann
 - i. Thank you card read from Mrs.Rose thanking the PTO for the Target gift card for the holiday staff gift.
 - b. Treasurer Report; Theresa Meshes
 - Changes for the month: Box Tops check received for \$108.70, Copies paid from family engagement which leaves that committee with \$607 left, Local Merchant has exceeded its expectations with \$819.54 profit, Lottery is at \$12,843 with an expected profit of \$11,043 after paying out all winners, Spring Fling has used \$1,000 of their budget for a deposit for a venue however it will not be cashed till the event takes place, taxes and fees increased to \$485 which is over budget as we had to pay a registration fee with the federal government which is \$275. Teacher grants were paid out last month with \$1084 left in the budget. There are outstanding lottery checks that winners have that need to be deposited. Our current bank available funds balance is \$11,028.85. Theresa is in discussion with the Illinois Department of Revenue as to whether or not the PTO has to pay back sales tax that we did not charge in previous years. At the moment they believe that we owe them \$8,000 (2017 to 2019). Theresa has been contacting attorneys to try to get clarification on this matter. There is an option for the PTO to have a service that costs \$2,000 a year however they would do all the legal documentation and accounting for us. Executive session will be held after today's meeting to discuss how the board wants to move forward with the accounting aspect of the PTO. This situation came to light when the couples night out wanted to serve alcohol at their event. Theresa went to apply for the liquor license and in doing so was denied us stating that we had to register as a business. She registered us as a business and in doing so they stated we need to be charging sales tax. The question at hand is do we need to pay sales tax because some think that we should not

have to, if we do need to be paying sales tax what do we need to be doing so on. The \$8,000 is based on the thinking that we needed to be paying sales tax on PTO directories, tickets for ice cream social, lottery tickets, raffle tickets and entry into our events. It is possible that we do not have to pay sales tax at all.

 - i. Mr. Walton reporting for the district office: Kindergarten registration was 2/7 at ARS. If you know of anyone who has a child in the district going into kindergarten please send them to the district office to register. The end of the 2nd trimester is Wednesday 2/23. Report cards will be sent home with ARS students and mailed to 5th grade families on the 23rd. Report cards for 6th-8th graders will be posted online by 3/2.

Monday is wear red, Tuesday is twin day, Wednesday is sports day, Thursday is school spirit & Friday is PJ day. They will be collecting food by grade levels. Winning grade level gets a prize! 8th grade graduation pictures are tonight 2/9 and they are starting to prepare for 8th grade end of the year activities.
